Now the parties hereby mutually agree and this agreement witnessed as under:

PPSES:

1. Collaborations in the area of mutual interest and exchange knowledge.
2. Utilization of Facilities / Laboratories at SPMSKASCC and PPSES by the faculty and students for the purpose of project assigned by PPSES.
3. Arranging training programs for professionals from PPSES covering applied Engineering subjects based on training need identification.
4. Exchange of academic/research information and related materials to facilitate joint publications by collaborating faculty members.
5. Promoting any related academic activities based on mutual agreement.
6. Industrial/Commercial/Residential site visits by faculty and students of SPMSKASCC on mutually suitable dates.
7. SPMSKASCC shall provide experts CVs or CVs of really interested candidates for acquiring projects/assignment, in which SPMSKASCC resources and Third and Final year students shall be given On-Job project training as an internship.
8. PPSES may recruit Third year and Final year candidate on project to project basis if required for working on live projects with or without fixed remuneration.



SPMSKASCC:

1. SPMSKASCC has agreed to provide Labs, infrastructure covering Training Space, Lighting, Furniture, Computer hardware, Projector, UPS Supply, training aids such as boards, markers, dusters etc. required for training.
2. SPMSKASCC shall arrange for necessary manpower support for conducting the Training.

Terms and Conditions:

1. Both the parties affirm their commitment to implement the activities and achieve the objectives mutually agreed upon.
2. Any conflicts between the parties shall always be decided by mutual consultation without any recourse to arbitration or other kind of legal remedy including resort to court of law.
3. Both parties shall use such material, name, logo, information as pre-approved and provided by each party for any of advertisements for promotional material on their web sites.
4. New assignments can be added during the course of implementation of MPU, if mutually agreed by both the parties.
5. Financial terms and conditions (if Arising) will be decided mutually on basis if any.

Validity of MOU:

This MOU shall remain in force and effect for Twenty-Four Months (24 Months). Either party can revoke this MOU by giving One Month prior notice.

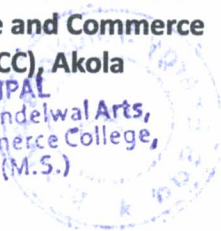
