

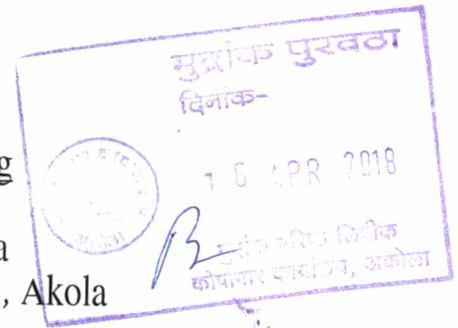



Para No.7 :- Accordingly party no.1 and party no.2 hereby agrees on following terms and conditions.

- a) Party No.1 will do the needful to take admissions of students in the college for the courses mentioned in para no. 3 After the successful completion of the course party no.1 will award the certificate to the student.
- b) Party no.1 will also provide infrastructure for conducting the training of the courses as per the availability of class rooms/hall on the days of training.
- c) Party NO.2 will take the whole responsibility of training the enrolled students in various aspects related with the above courses..
- d) Party No.2 will conduct training by providing supervisor, trainer and raw material required for the trainings.
- e) Party No.2 will give sufficient practice of the techniques taught during the training to make the enrolled students expert in the skills required to run their own self employment units/ jobs in related fields..
- f) Party No.2 will conduct the exam after completion of the course and convey the results to party no.2
- g) It is mandatory for party no.2 to provide training of best quality to the students. If the performance is not satisfactory this agreement shall stand terminated.

j) Party No.1 will pay 50% of the collected first installment to party no.2 in the beginning of the course and the rest amount due will be paid to party No.2 after deposition of complete fees by student and successful completion of the course.

k) If the student fail to remit the complete fees, party No.1 will not be liable to party No.2 for complete payment of the fees.

l) The training will commence only after admission of minimum 15 students for the course. In case less than 15 students are admitted in above said, course the course may be postponed /cancelled. In case the course is cancelled neither of the parties shall have any claim on each other & the fees collected from students will be refunded to them.

m). Party no. two will depute supervisor who will help for admissions ,make the time table for the courses as per the convenience of party no 1, supervise the whole training and assist in certification process .

n) Internship will be the mandatory part of the training. MCED will do the needful to depute the student in the firms concerned with the respective course for internship to make him/her expert and confidant in the regard .

o)Training required to develop the entrepreneurial soft skills will be the mandatory part of each conduced course .

p) MCED will help & guide the students who have successfully completed the course for their recruitment /setting up their own enterprise

q) The certificate of students will be signed by signatory authorities of both the parties.

r) The number and type of programs arranged in the college may be increased or decreased depending on the circumstances with mutual consent of both the parties.

s) This agreement is valid only for academic session 2018-19 after which it may be renewed with consent of both the parties.

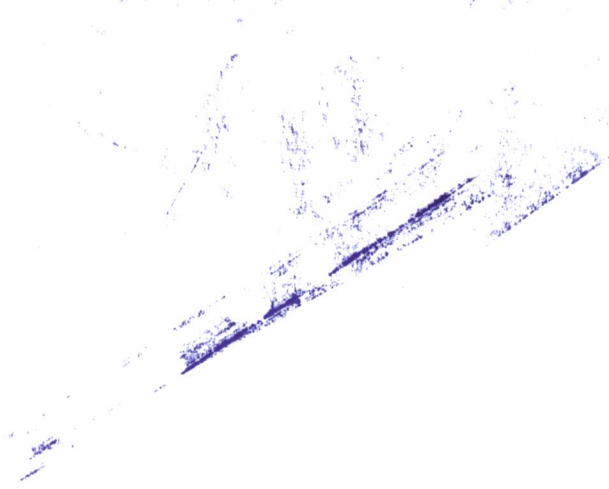
